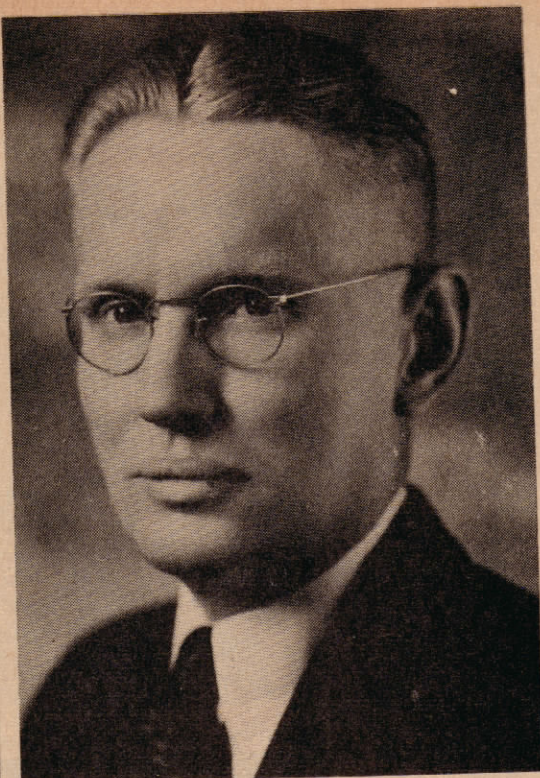

EXPLANATION OF PROPOSED AMENDMENT

THE PROPOSED AMEND-
MENT TO SECTION 1,
ARTICLE IX, OF THE CON-
STITUTION OF THE STATE
OF ILLINOIS:

The proposed Section 1 of Article IX of the Constitution differs from the present Section 1 of Article IX only by reason of the addition of the second paragraph, which is entirely new and which provides that the General Assembly shall have the power, in imposing an occupation or privilege tax, to exempt the business of selling food for human consump- tion, and gives the General Assembly the power to define the word "food."
